### Personal Health Grant Deadline

**T**he semi-annual deadline for **The Bennett Clayton Foundation Personal Health Grant** is quickly approaching. Deadlines of June 30th and December 31st have been established for this grant. Based on the following guidelines, BCF invites applications which will be considered after the June 30, 2007 deadline. Applicants may request up to \$2,500.00. The BCF Personal Health Grant will be issued to patients who have been diagnosed with Osteogenesis Imperfecta in accordance with the following guidelines:

- be a resident of Minnesota
- be 17 years old or younger
- have a physician's diagnosis of Osteogenesis Imperfecta (OI)
- show financial need
- funds to be used for one or more of the following:
  - orthotics/braces
  - physical/occupational therapy
  - dental intervention (due to OI)
  - wheelchair/walker/crutches (or other mobility aides)
  - hearing aids (due to OI). ■

### Personal Health Grant Awarded

**T**he first BCF Personal Health Grant was awarded in 2006 to a Minnesota child in need of special dental care as a result of her OI. Awards will be reviewed twice each year. See article above for requirements and application materials. ■

## News from OIF

**T**hanks to the Bennett Clayton Foundation, research into treatments and a cure for osteogenesis imperfecta (OI) is moving rapidly. Recent discoveries are extremely promising. A new recessive form of OI was discovered this year, bringing new understanding about how OI is inherited in families.

A major breakthrough in the search for a cure resulted in a new method to target and repair the faulty OI gene. This research is in large animal trials right now. This cure could be available for human trials in the next 5-10 years.

We are also studying new drug therapies that may increase bone density and strengthen the bones so that there are fewer breaks and deformities.

In April 2007, 60 of our nation's best OI researchers met to share their expertise and collaborate on a historic document that defines standards of care for treating people with OI. This will put an end to "best guess care", and begin a new era of evidence based quality medical care for people with OI of all ages. In concert with this, the Osteogenesis Imperfecta Foundation is developing Linked Clinical Research Centers to increase opportunities to improve care and speed up research progress. ■
